

NOTICE OF REGULAR MEETING

There will be a Regular Meeting of Andrews County Commissioners Court on Monday, March 13, 2017, beginning 9:00 A.M. in the Commissioners Courtroom, Room 107, Andrews County Courthouse, Andrews, Texas. The purpose of this meeting will be to consider the following agenda:

1. Call to Order
2. Pledge of Allegiance
3. Invocation
4. Approve the minutes from the previous meeting of Commissioners Court held on March 6, 2017.
5. Conduct public hearing, as required by §251.152, Texas Transportation Code, to consider the adoption of a county-wide speed limit of 15 miles per hour for all county maintained alleys, and to consider the installation of traffic control devices, specifically, rumble strips or speed bumps in selected alleys where speed control is necessary, pursuant to §251.016, 251.051, and 251.151 of the Texas Transportation Code, and §545.352 of the Texas Transportation Code.
6. Discuss and consider approving an Order Approving Imposition of Speed Limits in Alleys and Installation of Traffic Control Devices (Speed Bumps) in County Maintained Alleys effective March 13, 2017.
7. Discuss and consider approving the transfer of Augustine Lopez from Andrews County Precinct 4 as Equipment Operator at the rate of \$22.88 per hour to Andrews County Precinct 2 as Equipment Operator at the rate of \$22.88 per hour effective March 20, 2017.

8. Hear request from Julia Wallace, Executive Director of the Andrews Chamber of Commerce, for approval to host a 5K Walk/Run at the walking/running tract at the Andrews County Airport on April 22, 2017 for the Wild, Wild West Fest and take action as necessary.
9. Hear presentation from Victor Uvalle, Jr., ARM, CRM, CIC, Risk Management Consultant with the Texas Association of Counties regarding the Risk Management Services offered by the Texas Association of Counties.
10. Discuss and consider approving all action necessary related to the Community Legacy Fund including the Memorandum of Understanding.
11. Consider and approve the County Auditor's Monthly Report to Commissioners Court and District Judge as provided by Local Government Code 114.024 and 114.025 hereby identified in the Auditor's Red Book.
12. Open the floor for public forum.
13. Consider approving various budget amendments for the 2016-2017 Budget years under Local Government Code 111.010(d).
14. Consider approving the payment of financial obligations for Andrews County and cancel all warrants.
